## On the question of dating of "Passio Sancti Quirini"

There exist three early Christian written sources mentioning Saint Quirinus of Siscia. These are: "The Passion of Saint Quirinus"; an anthem in Prudentius' poem "On the Crowns" (written about 405 AD); and a passage in the "Chronicle" of Saint Jerome (written in 380 AD). Scholars differ on the dating of "The Passion of Saint Quirinus". A comparison between the "Passion" and the anthem by Prudentius leads some to the conclusion that the "Passion" is earlier then the anthem, and others to the contrary understanding. This way, the former suppose that the "Passion" was written in the 4th century, and the latter date it to the 5<sup>th</sup> century. The author compares the "Passion" with the "Chronicle" of Saint Jerome and finds literal coincidences between these two sources, which allows him to make a conclusion that Saint Jerome had the "Passion" before him when he was writing the "Chronicle". So the "Passion of Saint Quirinus" was written earlier then the "Chronicle", most probably in mid-4<sup>th</sup> century. There is the first Russian translation of the "Passion" below as well as commentaries.
